11:40 AM - 12:00 PM	Update from DBH	Sean Waldron	Brenda Willson talked about the last Leadership Meeting for the Regional Behavioral Health Boards. Different boards have different needs, strengths and areas that need to improve. This is a good opportunity to build the board we want for the future.  Sean shared that the proposed changes include the ability to continue working with the Health Districts if they chose or partnering with the Department of Health and Welfare. The boards would recommend funding for activities to the Department. The Department would recommend how the funding could occur following Department purchasing rules. If the recommendation follows the purchasing guidelines it would be approved. It is estimated that the Boards would have about \$15,000.00 to spend. The recommendation also must fit under the strategic goals of the Department. Admin support has been proposed to be taken on by a regional support person. This still needs to be fully approved.
