Meeting called to order at 3:05 p.m.

Board Attendance Review:

Attendance from last board meeting was reviewed. One Board member has missed the last two meetings and Elizabeth will reach out to them. Last meeting had low attendance and did not meet quorum due to an event at the Statehouse.

Respite Update – Mechelle Wilson

Mechelle provided a handout describing the current status of respite care along with the direction the Respite Committee is looking at. Mechelle stated that her presentation to the BHB will be postponed until November as the committee feels that there is more work that they want to accomplish first. The four types of respite care were explained; traditional, group, individual, and overnight/crisis. Contracts are currently being creating with providers in Ada, Valley, and Elmore Counties.

A model is currently being set up to place responsibilities of accountability to providers with occasional audits. Kim expressed that the board can oversee contracts but is not qualified to enforce them. Rob expressed concerns about fraud possibilities with the individual care model. Mechelle stated that fraud is possible with all models. The next steps of the model will be to focus on the administrative aspect and will require more involvement from CDHD.

Considerations for the Board and CDHD to look at are the financial management of services, which services will be provided by CDHD staff and what is to be contracted. A meeting will take place on Oct. 25th between DBH and CDHD and then Mechelle present the proposed model to the Board on the Nov. 10th meeting.
